Introduction

Dorstone Parish Council decided to produce a Neighbourhood Plan and formed a Steering Group to undertake this work for the Parish. The group has been meeting monthly since March and comprises of three sub-groups, one of which is the Consultative Group which oversees consultation with the Community including the preparation, distribution and analysis of this Questionnaire.

This report presents the basic results of that questionnaire which was conducted during November 2013. The report has been independently produced by Data Orchard CIC¹, commissioned by the Dorstone Neighbourhood Plan steering group, and based directly on the residents' responses to the distributed questionnaires.

Presentation of results

This report is mostly comprised of tables and charts presenting the results of the survey. Given the low number of the population and responses (19 out of a potential 30), percentages are not supplied. The tables show the number respondents who selected each option.

Survey methodology

Over the past four months, the Dorstone Neighbourhood Plan Steering Group talked to as many Parishioners as possible to determine the issues which people see as important. We have used this information to prepare this questionnaire. The questionnaire was developed by the Neighbourhood Plan steering group along with advice from Data Orchard before a final version was agreed in October.

During early November volunteers hand delivered questionnaires to all households in Dorstone parish. Residents were given sufficient questionnaires to allow completion by each adult member aged 16 and over, and a Youth Questionnaire for those young people aged 10-15. The completed questionnaires were sealed in an envelope provided, and collected by the person who delivered it within the following two weeks. The sealed returned envelopes were opened in the presence of an independent adjudicator, representative from Data Orchard, mostly on 26th November with further deliveries on the 28th November and the 3rd December.

Results

Response to the survey

The number of questionnaires returned, at least partially completed, was 19. According to the 2011 Census, the total number of children aged 10 to 15 years old, usually resident in the group parish on 27th March 2011 was 30². Based on this census figure, responses have been received from 63% of residents aged 16 and over.





Very happy


- Because I like all the houses and friends

- I feel it is important to respect the views of residents but we also should not be scared to innovate. Above all, we must protect Dorstone as the safe haven it is!

- I think Dorstone is a great place and shouldn't be changed too much. I don't want to see new, modern buildings popping up or even worse old, historic buildings knocked down. When building new houses they should only be kept to the style of those around them. That's the main thing for me. I would also like to see possibly a small village shop with all the household essentials like bread, milk, cheese and potatoes, it would be great if the produce could be locally made or grown.
